Wombat (6-Month) Limited Warranty

UplinkRobotics warrants that the Wombat inspection crawler is free from defects in materials and workmanship, and will, at its sole discretion, repair or replace any manufacturing defect for a period of six (6) months from the date of delivery to the original end-user purchaser, subject to the following terms and conditions. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

This warranty applies only to the original purchaser of the product. It is non-transferable and requires proof of purchase (receipt, invoice, or shipping confirmation) and the product serial number (located inside the battery tray) to initiate a claim.

Coverage

This limited warranty covers defects in materials and workmanship that arise under normal use consistent with the instructions and specifications provided by UplinkRobotics.

UplinkRobotics may, at its sole discretion, repair or replace defective components. UplinkRobotics reserves the right to refuse warranty service if the failure is not deemed to be the result of a manufacturing defect.

Exclusions

This warranty does not cover damage, defects, or malfunctions resulting from:

- Negligence, misuse, abuse, mishandling, or improper operation (examples include physically damaged camera gimbal/system, dirt or debris inside the camera gimbal/system, or other customer-caused damage).
- Normal wear and tear or cosmetic damage.
- Consumables, including but not limited to batteries.
- The controller and carrying case.
- Unauthorized or unqualified modification, alteration, or repair.
- Use of incompatible or defective accessories, consumables, or third-party products.
- Use in violation of applicable laws or regulations.
- Water damage or exposure to hazardous environments beyond design specifications.
- Damage occurring during shipping unless shipped in the original packaging.

Warranty Claim Procedure

To obtain warranty service, the purchaser must contact UplinkRobotics at support@uplinkrobotics.com or call 307.225.9210 within the warranty period. The purchaser must provide proof of purchase and the unit's serial number.

If UplinkRobotics determines the issue qualifies for warranty repair:

- Replacement parts may be shipped at no cost to the purchaser via ground shipping, along with installation instructions.
- If the product must be returned, UplinkRobotics will cover ground return shipping only if the robot and case are shipped in their original box. If original packaging is not used, the purchaser is responsible for shipping both ways.
- Faster shipping methods are available at the purchaser's expense.

If UplinkRobotics determines the claimed repair is not covered under warranty:

- UplinkRobotics will provide a repair quote before any work is performed.
- If the claim is determined to be due to negligence or customer-caused damage, the purchaser will be invoiced for shipping costs. The product will not be returned until the invoice is paid in full.

Post-Warranty Support

After the warranty period, UplinkRobotics continues to provide technical support for the Wombat. Repairs performed outside of warranty will be chargeable, with costs dependent on the extent of the damage. Quotes will be provided prior to work or part replacement.

Limitations of Liability

This warranty is the sole and exclusive express warranty for the Wombat inspection crawler. To the fullest extent permitted by applicable law, any implied warranties, including implied warranties of merchantability and fitness for a particular purpose, are limited in duration to the six (6) month warranty period stated above. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

UplinkRobotics is not responsible for:

- Downtime, lost revenue, or business interruption caused by product failure.
- Incidental, consequential, or indirect damages arising from or related to product use, except for damages for personal injury in the case of consumer goods where such limitation is prohibited by law.
- Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

Governing Law

This warranty is governed by and construed in accordance with the laws of the State of Wyoming, USA, without regard to its conflict-of-laws principles. Any disputes shall be subject to the exclusive jurisdiction of the courts located in Albany County, Wyoming. Purchaser consents to the personal jurisdiction of such courts and waives any objection to such venue.

Severability. If any provision of this warranty is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

This warranty is provided subject to UplinkRobotics' General Terms and Conditions of Use.
